COMES NOW Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its *Prehearing Conference Proposal*, states as follows:

1. On April 6, 2018, the Commission issued its *Order Directing Filing*, directing the parties to file a proposed procedural schedule or proposed dates for a procedural conference no later than May 9, 2018.
2. Counsel for Staff communicated with and/or to Counsel for Respondent on April 11, April 30, and May 2.
3. The April 30 and May 2 communications contained a draft Proposed Procedural Schedule containing the following suggested dates and deadlines:

4. The April 30 communication also contained suggested dates of May 29 and June 11 for a prehearing conference.

5. Counsel for Respondent has indicated that June 11 is an agreeable date on which to hold a prehearing conference.

WHEREFORE, Staff respectfully requests the Commission issue an order setting a prehearing conference for June 11, and to grant any such further relief as is just in these circumstances.
