Purpose: Adjust the value of the IntraLATA Dialing Parity Cost Recovery Surcharge

On August 01, 2002, McDonald County Telephone Company (McDonald County), an Incumbent Local Exchange Carrier (ILEC), filed a proposed revision with the Public Service Commission (Commission) to its P.S.C. MO No. 5 Telephone Service Tariff. The proposed change will:

• Increase the rate for a temporary surcharge to recover the cost of implementation of IntraLATA equal access.

## I. Background

On June 10, 1999, the Commission approved McDonald County's proposed IntraLATA Toll Dialing Parity (ILDP) Implementation Plan in its Report and Order (Order) in Case No. TO-99-515. ILDP allows a Local Exchange Carrier (LEC) customer to direct-dial a long distance number (1+ or 0+) without first dialing an access code, by using a preselected toll provider. The Commission's Order directed McDonald County to submit data when available showing the cost of ILDP, and to then submit revised tariffs as necessary for recovery of those costs. In accompanying cases at that time, certain other LECs received similar directions.

McDonald County is recovering its costs of implementation of IntraLATA presubscription by applying a surcharge to its Carrier Common Line (CCL) access charge, to continue for up to three (3) years following the Effective Date of the initial filing. The amount of the surcharge, known as the Equal Access Cost Recovery (EACR) surcharge, was set at \$0.00205, which is being applied monthly to all intrastate originating access minutes. The surcharge was approved by the Commission effective July 12, 2000, under File No. 2000 01159.

McDonald County accumulated actual financial data relevant to its progress in recovery of the costs of ILDP through the surcharge. From that data, it appears evident that recovery of the costs will not be complete within the expected three-year period with the current EACR rate. With the instant filing, McDonald County now proposes to increase its surcharge to \$0.00297 for the remaining portion of its original three-year period, which will terminate on July 12, 2003. In support of this filing, McDonald County has submitted a Proprietary financial analysis of the accruing and projected revenues and costs of the ILDP services.

In January, 2002, Case Nos. TT-2002-310, TT-2002-311 and TT-2002-312 were established and consolidated, which were to address the tariff proposals of Mid-Missouri Telephone Company (Mid-Mo) and other ILECs with similar expected EACR shortfalls. The proposed changes were to extend the collection period of the temporary surcharge at its current rate until the costs of ILDP were fully recovered. On April 25, 2002, the Commission issued its Order Rejecting Tariffs in the consolidated cases, rejecting those proposed tariff pages that would have extended the EACR collection period. On May 01, 2002, Mid-Mo and others submitted new tariff pages to increase the EACR surcharges for the remainder of the original three (3) -year recovery period. File Nos. 200200933, 200200934 and 200200935 were approved by the Commission to raise the surcharges effective June 01, 2002.

Currently before the Commission at this writing are File Nos. 200300072 (Ellington Telephone Company), 200300090 (Peace Valley Telephone Company), and 200300099 (Lathrop Telephone Company), each of which is submitted for the same purpose. The table below shows the status of the various ILEC and EACR surcharges for reference with the proposed changes in rates.

## **II. Summary Recommendation**

The Telecommunications Department Staff (Staff) has reviewed the proposed tariff sheet, and has no objections to the new rate becoming effective. Except as noted above and below, Staff is unaware of any other filings that may directly affect, or be affected by, this filing. Staff has no objections to the filing.
