AMENDED NOTICE OF DISMISSAL OF APPEAL

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), the Missouri Energy Development Association ("MEDA") and United for Missouri, Inc. ("UFM"), and hereby give notice that they have dismissed their appeals of the Commission's *Report and Order* in this case. The now-dismissed appeals arose from the Commission's decision to create the Industrial Aluminum Smelter ("IAS") rate class and thereby give that class a rate having no relationship to the cost to serve that class, and having no basis in any difference in the character of the service Ameren Missouri provides to that class as opposed to service provided to any other class. A copy of the dismissal filed in the Missouri Court of Appeals – Western District, is attached to this Notice.

Although the appeals have been dismissed, please take note that Ameren Missouri, MEDA, and UFM continue to believe, as reflected in their briefs filed in the Court of Appeals, that the decisions reflected in the *Report and Order* regarding the IAS class are unlawful and unreasonable, and that any similar order in a future case would for the same reasons also be unlawful and unreasonable. However, given the circumstances of the only customer in the IAS class, and the likely impracticality of obtaining effective relief because of that customer's bankruptcy filing and overall financial condition, Ameren Missouri, MEDA, and UFM determined it appropriate to dismiss the appeals.
