**ORDER RECOGNIZING NAME CHANGE**

Issue Date: August 30, 2018

Effective Date: September 2, 2018

On August 23, 2018, New Florence Telephone Company, New London Telephone Company, Orchard Farm Telephone Company, and Stoutland Telephone Company filed notice that they each intend to adopt Missouricom as a fictitious name under which they intend to do business. Each company also issued revised tariffs to reflect its new name. The revised tariffs carry a September 2 effective date. The Staff of the Commission responded on August 30, indicating the companies have complied with all statutory and regulatory requirements for changing their name. Staff recommends the Commission recognize the name change. The Commission will do so. The revised tariffs will be allowed to go into effect by operation of law on their effective dates.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of New Florence Telephone Company to New Florence Telephone Company d/b/a Missouricom.
2. The Commission recognizes the name change of New London Telephone Company to New London Telephone Company d/b/a Missouricom.

3. The Commission recognizes the name change of Orchard Farm Telephone Company to Orchard Farm Telephone Company d/b/a Missouriicom.

4. The Commission recognizes the name change of Stoutland Telephone Company to Stoutland Telephone Company d/b/a Missouriicom.

5. This order shall be effective on September 2, 2018.

6. This file shall be closed on September 3, 2018.
