Southwestern Bell Telephone Company, pursuant to §386.420 RSMo (1994) and 4 CSR 240-2.075, respectfully seeks to intervene in this proceeding and states:

- 1. Southwestern Bell is a Missouri corporation duly authorized to conduct business in Missouri with its principal office at One Bell Center, St. Louis, Missouri 63101. Southwestern Bell is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide "telecommunications service" within the State of Missouri as each of those phrases are defined in §386.020 RSMo (1994).

3. In this docket, Global Time, Inc. seeks a certificate of service authority to provide intrastate interexchange and local exchange telecommunications service in the State of Missouri. Global Time also seeks classification as a competitive telecommunications company and the waiver of certain Commission rules and statutory provisions.

- 4. Southwestern Bell seeks to intervene in this proceeding because it has a direct interest in the Commission's decision on Global Time's Application. Southwestern Bell is authorized to provide local exchange telecommunications services and exchange access services within the State of Missouri. Pursuant to tariffs on file with the Commission, Southwestern Bell is authorized to provide the type of services within the State of Missouri that Global Time seeks to provide. Global Time's services will be offered in direct competition with Southwestern Bell if this application is granted.
- 5. Southwestern Bell's interests as a local exchange telecommunications service provider differ from those of the general public. No other party to this proceeding will adequately protect Southwestern Bell's interest.
- 6. Granting of this intervention will be in the public interest because Southwestern Bell will bring to this proceeding its expertise and experience as a telecommunications provider.

WHEREFORE, Southwestern Bell respectfully requests the Commission to grant this Application to Intervene.
