## **AMENDMENT TO APPLICATION**

COMES NOW NetLojix Telecom, Inc. ("NetLojix" or "Applicant"), by its undersigned counsel and in response to the Commission's <u>Notice of Deficiency (Notice</u>) issued December 2, 1999, submits this Amendment to Application.

- 1. The Commission's <u>Notice</u> indicated that the Commission could not proceed until NetLojix clarified the relief it seeks herein. NetLojix provides this Amendment to Application in an effort to resolve the inconsistent references to the competitive classification sought in the Application.
- 2. NetLojix seeks classification as a competitive telecommunications company pursuant to the terms of Section 392.361 RSMo., as stated in the first paragraph of page 1 of the Application. On page 4 and in the WHEREFORE paragraph (prayer clause) of the Application, NetLojix inadvertently referenced only classification of its *services* as competitive, when it should have referenced classification of NetLojix as a competitive telecommunications *company* pursuant to the terms of Section 392.361. Classification as a competitive telecommunications company requires that all services of the company be classified as competitive.
- 3. NetLojix requests correction of the references to classification of services, as follows: page 4, last paragraph, the first sentence should be corrected to read: "NetLojix also seeks

classification as a competitive telecommunications company with accompanying reduced regulation, pursuant to § 392.361 RSMo." The second sentence of that paragraph should be disregarded. On page 7, in the WHEREFORE paragraph, the third and fourth lines should read "intrastate interexchange telecommunications services, classify Applicant as a competitive telecommunications company, and grant a waiver of the statutes and regulations referenced above." With these corrections, the inconsistency in the references to competitive classification should be resolved.

WHEREFORE, with the above-referenced corrections to the Application, NetLojix respectfully requests the Commission issue Certificate of Service Authority, classify NetLojix as a competitive telecommunications company, and waive the rules and statutes as referenced in the Application.
