**LATE-FILED EXHIBIT CONCERNING
APPLICATION FOR CHANGE OF NAME AND MOTION FOR EXPEDITED
TREATMENT TO EFFECTUATE THAT CHANGE**

Joint Movants Aquila, Inc. (“Aquila”) and Great Plains Energy Incorporated (“Great Plains Energy”) through undersigned counsel hereby submit as a late-filed exhibit a receipt-stamped copy of the Registration of Fictitious Name that Great Plains Energy filed on July 14, 2008 with the office of the Missouri Secretary of State. The submission of this document is required pursuant to 4 CSR 240-2.060(5)(B), and Joint Movants indicated in their July 2, 2008 application for name change and request for approval of related tariff sheets that they would submit this document as a late-filed exhibit. Joint Movants respectfully request that the Commission approve the requested name change and corresponding tariff sheets on an expedited basis to be effective July 18, 2008.

In support hereof, Joint Movants provide as follows:

1. By a Motion for expedited treatment submitted July 2, 2008, Joint Movants requested that the Commission approve the requested name change and the tariff sheets necessary to accomplish that change to be effective on July 14, 2008, to coincide with the consummation of Great Plains Energy’s acquisition of Aquila. By order issued July 9, 2008, the Commission denied that request “based upon the lack of harm to either the applicants or their customers, and based upon the applicants failure to comply with Commission Rule 4 CSR 240-

2.060(5)(B),” which requires the submission of evidence of registration of the name change with the Missouri Secretary of State.

2. In their July 2, 2008 name change submission, Joint Movants provided a statement, clearly setting out both the old name and the new name. Joint Movants also provided an adoption notice and revised tariff sheets reflecting the proposed name change. With today’s submission of the Registration of Fictitious Name, Joint Movants have fully satisfied the requirements of 4 CSR 240-2.060(5). Having done so, Joint Movants again move for expedited treatment and respectfully request that the Commission approve the name change and tariffs effectuating that change to be effective July 18, 2008.

3. Good cause exists for such expedited consideration. Customers will benefit from effectuating the name change as soon as possible. In its Report and Order in Case No. EM-2007-0374 the Commission approved the transaction as being in the public interest, citing the significant synergy savings that will result from the transaction. Consistent with the Joint Movants’ intent, as previously indicated to the Commission, the transaction closed on July 14, 2008. There has been and will likely continue to be a considerable amount of media coverage and other public messages announcing the close of the transaction. Allowing the name change to become effective as soon as possible following the close of the transaction will help to minimize any customer confusion associated with the integration process. It is confusing for Aquila customers to see and read that Great Plains Energy has acquired Aquila, but at the same time to continue receiving bills and other official correspondence from Aquila as though nothing has changed.

4. Moreover, there is no negative effect associated with granting this motion for expedited treatment. Staff and the Office of Public Counsel both commented on the proposed name change. Neither had any substantive issues with the proposed new name. In fact, Staff

recommended that the Commission approve the name change and tariff sheets effective July 14, 2008 for good cause shown subject only to the applicants' submission of evidence of the name change registration with the Secretary of State. By submitting herewith a receipt-stamped copy of the Registration of Fictitious Name, Joint Movants have fully complied with the Commission's regulations.

5. The only other issue raised concerning the proposed name change was Office of Public Counsel's concern about the corresponding tariff sheets potentially becoming effective prior to the effective date of the Report and Order in Case No. EM-2007-0374. That concern is no longer relevant because that Report and Order became effective July 14, 2008.

6. In sum, this submission and the effectiveness of the Commission's Report and Order in Case No. EM-2007-0374 fully address the issues raised by Staff and the Office of Public Counsel concerning Joint Movants' request for expedited treatment. No one asserts that expedited treatment of the name change request will harm customers, and in fact, no such harm will occur. To the contrary, expedited treatment will benefit Aquila's customers.

7. Joint Movants submitted this request as soon as possible. The Registration of Fictitious Name with the Missouri Secretary of State could not be submitted until the acquisition had been consummated. The Commission's Report and Order authorizing such consummation was not effective until July 14, 2008. Consequently, Joint Movants could not obtain the registration required by the Commission prior to that date, and therefore could not previously address the Commission's concern regarding that registration.

WHEREFORE, Movants respectfully request that the Commission (i) accept the late-filed exhibit attached hereto; (ii) authorize the name change requested by the Joint Movants in their July 2, 2008 submission, and (iii) approve the tariff sheets effectuating that change on an expedited basis to go into effect July 18, 2008.
