In the matter of Ellington Telephone Company
of Ellington, Missouri, for authority
to file tariffs increasing rates for telephone
service provided to customers in the Missouri
service area of the Company.

SUSPENSION ORDER

On November 13, 1978, Ellington Telephone Company of Ellington, Missouri, submitted to this Commission revised tariffs reflecting increased rates for telephone service provided to customers in the Missouri service area of the Company. The proposed tariffs have a requested effective date of December 15, 1978.

To allow sufficient time to study the effect of the proposed increases and to determine if they are just, reasonable and in the interest of the public, it is the opinion of the Commission the proposed tariffs should be suspended for a period of one hundred twenty (120) days beyond December 15, 1978, the requested effective date, unless otherwise ordered by this Commission.

It is, therefore,

ORDERED: 1. That the following tariff sheets submitted on November 13, 1978, by Ellington Telephone Company of Ellington, Missouri, for the purpose of increasing rates for Telephone service provided to customers in the Missouri service area of the company, be, and the same are hereby suspended for a period of one hundred twenty (120) days beyond December 15, 1978, the requested effective date, to April 14, 1979, unless otherwise ordered by this Commission.
