

ORDER APPROVING RATE SHEET

By its Order in this case on October 2, 1980, this Commission authorized
Trails West Sewer Company of Columbia, Missouri to file an original tariff for
sewer service rendered on and after October 14, 1980, exclusive of gross receipts
and franchise taxes.

On October 14, 1980, Trails West Sewer Company, of Columbia, Missouri,
submitted a tariff sheet for Commission review and approval, to comply with the
Commission's Order.

The Commission is of the opinion the proposed rate submitted by
Trails West Sewer Company of Columbia, Missouri, comply with its Order issued
on October 3, 1980, and said tariff sheet should be allowed to become effective
on November 1, 1980.

It is, therefore,

ORDERED: 1. That the tariff sheet submitted on October 14, 1980, by
Trails West Sewer Company, of Columbia, Missouri, for the purpose of setting
rates for sewer service provided to customers in its Missouri service area be,
and it is, hereby approved and made effective on November 1, 1980.

ORDERED: 2. That this Order shall become effective on the date
hereof and the Secretary of the Commission shall serve a certified copy of
same upon each party of record and a copy on all other interested parties.
