MOTION FOR EXTENSION OF TIME

COMES NOW, Union Electric Company, d/b/a Ameren Missouri (“Ameren Missouri” or “Company”), and for its Motion for Extension of Time states as follows:

1. After receiving a short extension of time from the Commission to file a motion for summary determination (from the original deadline of October 30, 2014 to November 21, 2014), on November 14, 2014 Mr. Jimmie E. Small (Complainant) filed his Motion for Summary Determination in this case.

2. 4 CSR 240-2.117(1)(C) provides that a response may be filed thirty days after the motion is served.

3. Counsel for Ameren Missouri, Sarah E. Giboney, requests a one-week extension of time, to December 22, 2104, to file a response to Complainant’s Motion for Summary Determination, due to the press of business facing said counsel including preparation for a 4-day trial which begins Monday, December 15, 2014.
