## THE OFFICE OF THE PUBLIC COUNSEL'S RESPONSE TO ORDER DIRECTING FILING AND REQUEST FOR ADDITIONAL TIME TO RESPOND TO LIBERTY UTILITIES' TARIFF FILINGS AND THE STAFF'S RECOMMENDATION

- 1. On August 30, 2019, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities ("Liberty Utilities") filed its Revised Weather Normalization Adjustment Rider.
- 2. On September 3, the Commission issued its *Order Directing Staff Recommendation* and *Setting Time for Responses*. The Commission ordered Staff to file its *Recommendation* on September 11, and Public Counsel was also ordered to file its response today as well.
- 3. Today, at 1:00 p.m. Public Counsel received notice of Liberty Utilities' WNAR Substitute Filing Letter, its "REDLINE" and "CLEAN" tariffs and its "WNAR Filing Workpapers Oct-19-revised.xlsx."
  - 4. The Staff *Recommendation* was filed at 4 p.m.
- 5. Public Counsel will require at least a day to review the tariffs and the Staff's *Recommendation* and, consequently, requests the Commission grant Public Counsel's Motion for

an Extension of Time to review the Liberty Utilities' tariff related filings and the Staff's *Recommendation* until September 13 at 10 a.m.

WHEREFORE Public Counsel requests the Commission grant Public Counsel sufficient time to review Liberty Utilities' filings made today and the Staff's Response before being required to file its Response to these documents.
