### **ORDER DIRECTING NOTICE AND ADDING PARTY**

On September 28, 2007, the Staff of the Missouri Public Service Commission filed a report pursuant to Section 392.245.5, RSMo (Supp. 2006), regarding conditions for competitive classification for Embarq Missouri, Inc., d/b/a Embarq's competitively classified exchanges. Because Embarq is a necessary party for a full adjudication of this matter, the Commission will add Embarq as a party to this case.

In addition, the Commission will issue notice and set a date for other interested parties to file requests to intervene. If no party requests a hearing, the Commission may make its determination based on the verified pleadings and recommendations.<sup>1</sup>

### **IT IS ORDERED THAT:**

1. Embarq Missouri, Inc., d/b/a Embarq, is made a party to this case.
2. The Data Center of the Missouri Public Service Commission shall send notice of this application to all certificated competitive local exchange carriers, and to all incumbent local exchange carriers in the state of Missouri.
