ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING REQUESTS TO INTERVENE, ESTABLISHING TIME FOR FILING RECOMMENDATIONS, AND GRANTING IN PART AND DENYING IN PART THE MOTION FOR EXPEDITED TREATMENT

Issue Date: July 13, 2009 Effective Date: July 13, 2009

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene, for the filing of recommendations, and granting in part and denying in part the motion for expedited treatment.

On July 10, 2009, Southwestern Bell Telephone Company, d/b/a AT&T Missouri, filed an application under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Commission review and reverse a decision of the North American Numbering Plan Administrator, NeuStar, Inc., to withhold certain numbering resources from AT&T Missouri in the form of five thousand (5000) consecutive numbers, such that the numbers are within (1) the 816 NPA; (2) the Kansas City rate center; (3) a single NXX (or "prefix"); and (4) the XXXX range of 1000 through 5999 to service the needs of Metropolitan Community College ("MCC") in the Kansas City, Missouri area. AT&T Missouri indicated that if the requested numbering

resources were not available, they request any other suitable numbering resources that meet the MCC's needs. The numbering resources are requested in order to serve all eight of its campus locations through the upgraded telecommunications services arrangement which will utilize a Wide Area Network to accomplish inter-campus transmission of traffic. The numbering resources will also support campus growth.

AT&T Missouri has requested expedited treatment and has requested the Commission act on the request within ten (10) business days. AT&T Missouri noted that although MCC's plans call for number activation by September 15, 2009, MCC would like to know if the numbers requested are available within 30-45 days. AT&T Missouri requests Commission action within 10 business days in order for AT&T Missouri to timely file a new request with NANPA for the release of the numbering resources.

On July 10, 2009, the Staff of the Missouri Public Service Commission filed a Reply in Opposition to AT&T Missouri's Motion for Expedited Treatment. Staff opposes AT&T Missouri's motion because Staff would only have two business days to review the filing and necessary information and prepare and file a Staff Recommendation in sufficient time to allow the Regulatory Law Judge to draft an order to present to the Commission on the July 15 Agenda.

The Commission concludes that good cause has been shown pursuant to 4 CSR 240-2.080(16) to act on the Application with Expedited Treatment, although not within the 10 business day time frame as requested. The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In

addition, the Data Center shall send a copy of this order to the North American Numbering

Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and will

establish a date by which any other party wishing to respond must file a recommendation.

IT IS ORDERED THAT:

1. Southwestern Bell Telephone Company, d/b/a AT&T Missouri's Motion for

Expedited Treatment, is granted in part and denied in part.

2. The Data Center shall send a copy of this order to each certificated

interexchange and basic local exchange telecommunications company in Missouri and to

the North American Numbering Plan Administrator, NeuStar, Inc.

3. Any party wishing to intervene or to request a hearing shall do so by filing an

- 5. Any other party that wishes to file a recommendation regarding Southwestern Bell Telephone Company, d/b/a AT&T Missouri's application shall do so no later than July 17, 2009.
