NOTICE OF LOCAL PUBLIC HEARING REGARDING PROPOSED RATE INCREASE

Based upon a request by the Office of the Public Counsel (OPC), a state agency responsible for representing the interests of consumers before the Missouri Public Service Commission (Commission), the Commission will be holding a local public hearing regarding proposed changes to the customer rates and charges of P.C.B., Inc. (Company). The purpose of this local public hearing is to receive customer comments about proposed changes to the Company's rates and charges, and to bring service-related problems to the Commission's attention.

The local public hearing will be held June 12, 2014, at Jefferson College-Hillsboro Campus, Arts & Sciences I Building, Room 117, 1000 Viking Drive, Hillsboro, Missouri. The night's activities will begin with an informal question-and-answer session starting at 6:00 p.m. – with the local public hearing starting immediately after the informal session. The facility at which this local public hearing is being held meets the accessibility standards required by the Americans With Disabilities Act. Any person who needs additional accommodations to participate in the local public hearing should call the Commission's Hotline at 1-800-392-4211 (voice), or Relay Missouri at 711, no later than the end of business on June 11, 2014.

On September 9, 2013, the Company submitted a request for a 100% increase in its regular monthly service charges. Subsequent to that request being submitted, the Commission Staff and the OPC conducted an audit of the Company's books, records and operations. As a result of negotiations between the Company and the Staff regarding the Company's request and the Staff's audit, the Company and the Staff reached an agreement that would result in the proposed rates shown in the table at the end of this notice. At this point, the OPC has not entered into any agreements regarding increases in the Company's rates.

Any customer that has questions about the local public hearing, that has comments about the Company's proposed revisions to its rates and charges, or that has comments regarding service-related problems should contact the Commission Staff and/or the OPC no later than the end of business on June 11, 2014.
