For this information the Staff requests goals and objectives in effect during the timeframe covered by the 2004-2005 and 2005-2006 ACA and the corresponding dollar value or stock equivalent of bonuses awarded (whether paid or accrued). Provide any compensation committee minutes that document the basis for and quantification of incentive awards and bonuses.

2. On September 18, 2008, the Staff filed a Motion to Compel that included a request for the information identified above.

- 3. On October 16, 2008, Laclede provided information regarding the amount of cash bonuses and the goals and objectives in effect. The documents are labeled "draft" and may not be the final bonus information. Laclede did not provide information regarding how the cash bonus was actually calculated or how the goals and objectives were met. Laclede did not provide information about the amount of stock or other non-cash bonuses awarded, the computation of the awarded stock or other bonuses, or compensation committee minutes or documents that detail the basis for and quantification of incentive awards and bonuses.
- 4. Laclede has not fully complied with the Staff's request and the Staff repeats its motion to compel Laclede to produce the requested bonus information as well as other documents previously requested.
