**NOTICE OF AGREEMENT**

COMES NOW Missouri-American Water Company (MAWC or Applicant), and hereby notifies the Missouri Public Service Commission (Commission) of MAWC's Agreement with the Commission Staff (Staff) Recommendation filed on February 19, 2010 as corrected on March 3, 2010:

1. On February 19, 2010, the Staff filed a Recommendation that contained a Memorandum describing Staff's review of MAWC's Petition.
2. On March 3rd, 2010, the Staff filed a Notice of Correction to Recommendation that corrected certain aspects of the staff Memorandum filed previously.
3. Having reviewed the February 19, 2010 Staff Recommendation, Memorandum and attachments thereof (as modified by the March 3rd, 2010 Notice of Correction, MAWC hereby notifies the Commission that it is in agreement with the rates recommended in the Corrected Staff Memorandum and asks that the Commission issue an order as requested by the Staff.
4. The Commission previously suspended MAWC's proposed ISRS tariff sheet (YW-2010-0413) until April 22, 2010. Because there appears to be no disagreement among the parties and no necessity for a hearing, MAWC would ask the Commission to act at its earliest convenience.

WHEREFORE, for the foregoing reasons, MAWC respectfully request the Commission consider this Notice of Agreement and thereafter issue an Order authorizing MAWC to file a tariff sheet that corresponds to the Infrastructure System Replacement Surcharge identified in the Corrected Staff Recommendation.
