1. At page 5, paragraph 3
Hon. Judge Bushmann caused to
be entered the following arbitrary
and capricious order;

No later than March 22, 2012,
Mr. Small may amend his
complaint as described in the
body of this order, stating in a
clear and concise manner any
additional issues for determination
which the Commission has the
statutory authority to consider and
which have not already been
dismissed by the Commission.

2. Complainant did not
receive the Commission's Order
of denial dated March 14, 2012
until Wednesday March 21, 2012.

Notice of Appeal
to the next Court of Missouri
Appeal Jurisdiction, as
Appropriate, Co. County Venue.

3. Complainant's actual possession
of the March 2012 denial of
Reconsideration Order not
sooner than March 21, 2012,
denies the ADA reasonable or
rational opportunity to meet
the clear and concise
standard within less than
24 hours, in which to file,
draft, assimilate, and
serve his Amended Complaint
as granted at page 5, paragraph
3, entered March 14, 2012.

4. The balance of grounds for
interlocutory Appeal are decisions
taken as arbitrary, capricious,
not in accord with due process
of law, equal opportunity as
related to this and **Impartial Notice**

4. The Commission's denial of default judgment was entered without proper discovery. And the March 14, 2012 adverse decision ignores ex parte communications - exchange of "substantive issues" as reflected above the signature of Chairman G. W. and Republican St. Louis Counsel, which has denied small basic and fundamental rights to a fair and impartial decision [EC-2012-0050]. That at least three separate ex parte communications did not just occur which resulted in an abuse of discretion on March 14, 2012 by Senior, Political figure, Senior Regulatory Law Judge, Michael Bushman.

5. That as a direct and proximate result of the ex parte communication complained of the April 11, 2012 Hearing would involve An-4 Adversarial Proceeding.
