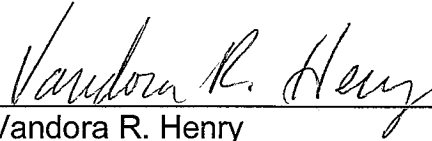
**NOTICE OF VOLUNTARY DISMISSAL**

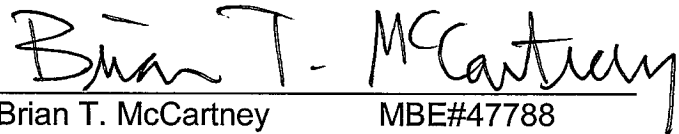
1. After voluntary negotiation, Ms. Henry and MGE have agreed to a satisfaction of this matter which resolves this Complaint.
