



On October 29, 1999, the following parties appeared and participated in the prehearing conference: Fiber Four, the Commission Staff (Staff), the Office of Public Counsel (Public Counsel) and AT&T Communications of the Southwest Inc. (AT&T). As a result of the prehearing conference, the parties were able to agree on a schedule of proceedings as follows:


