

## RESPONDENTS' MOTION TO DISMISS RESPONDENT EMPLOYEES

Come now respondents, and for their Motion to Dismiss Respondent Employees state as follows:

- 1. The Complaint filed herein before the Missouri Public Service Commission (the "Commission") raises issues concerning the provision of electric service to business accounts located at 8350 North Broadway in the City of St. Louis.
- 2. The Complaint names as respondents not only respondent AmerenUE, a public utility, but also three of its employees, Michael Foy, Leroy Ettling and Sherry Moschner (the "respondent employees").
- 3. The Complaint, paragraph 2, alleges that the actions of respondent employees on which complainants based their Complaint were "done within the scope of their employment on Respondent AmerenUE's behalf."
- 4. While respondents deny that the Complaint has any merit, complainants themselves concede that the actions of respondent employees of which they complain

were all done within the scope of their employment. As a result, complainants have failed to state a claim against respondent employees upon which relief can be granted.

WHEREFORE, respondents respectfully request that respondents Michael Foy,
Leroy Ettling and Sherry Moschner be dismissed from the Complaint and for such other
and further relief the Commission deems just and proper.
