**FIBER FOUR CORPORATION'S
MOTION TO WITHDRAW TARIFF FILING**

Comes now Fiber Four Corporation ("Fiber Four") and for its Motion to Withdraw Tariff Filing states to the Missouri Public Service Commission ("Commission") as follows:

1. On June 25, 1999, Fiber Four filed its intrastate long distance message telecommunications service tariff proposing to implement rates, terms and conditions for the provision of intrastate toll services in the exchanges served by Rock Port Telephone Company, Holway Telephone Company, KLM Telephone Company and Iamo Telephone Company. Fiber Four proposed to provide intrastate long distance services in those exchanges using the fictitious names Rock Port Long Distance, Holway Long Distance, KLM Long Distance, and Iamo Long Distance. Since Fiber Four already held a certificate to provide interexchange telecommunications service in Missouri, the proposed tariff was filed as a revision to the existing tariff and bore an issue date of June 25, 1999, and an effective date of July 26, 1999.

2. Although the Commission accepted the tariff for filing, the company was later notified that the tariff was rejected because the company proposed to do business under more than one fictitious name. On July 2, 1999, Fiber Four filed a Motion to Reinstate and Approve Tariff Filing for an Interim Period of Time explaining that the four local exchange companies were under time constraints to be able to provide interexchange services to their customers and it would take some



time to prepare and filed four separate applications and tariffs. On July 14, 1999, the Commission Staff recommended that the tariff be rejected.

3. Fiber Four has now filed four separate applications for interexchange authority for each fictitious name under which the company proposes to do business and individual tariffs for each of the fictitious names. At the same time, Fiber Four filed Motions to Expedite requesting that the individual tariffs be approved on an expedited basis so that the companies would have the authority and an approved tariff by the dates each company implemented for intraLATA dialing parity. For this reason, Fiber Four now withdraws its original tariff filing.

Wherefore Fiber Four Corporation respectfully requests that the Commission grant its Motion to Withdraw Tariff Filing and for any other relief appropriate in the circumstances.
