MOTION FOR ADDITIONAL TIME TO FILE STIPULATION AND AGREEMENT AND PROCEDURAL SCHEDULE

COME NOW Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") (collectively, the "Company") and hereby file its Motion For Additional Time To File Stipulation And Agreement and Procedural Schedule. In support thereof, the Company states as follows:

- 1. On October 30, 2015, the Commission issued its *Order Granting Motion for Extension of Time to File Stipulation and Agreement and Procedural Schedule* which directed that KCP&L and GMO file a Stipulation and Agreement by November 6, 2015 and a joint revised procedural schedule by November 10, 2015.
- 2. On November 9, 2015, the Commission issued its *Second Order Granting Motion* for Extension of Time to File Stipulation and Agreement and Procedural Schedule which directed that KCP&L and GMO file a Stipulation and Agreement by November 13, 2015 and a joint revised procedural schedule by November 17, 2015.
- 3. The Company advises that although significant progress has been made in drafting a Non-Unanimous Stipulation and Agreement, it will not be possible to file it today (November 13, 2015). As such, in an effort to resolve as many issues as possible by an agreement which does not require the necessity of a hearing, the Company requests that the Commission extend the deadline for filing a Stipulation And Agreement from November 13 to

November 18, 2015, and allow the parties to propose a revised procedural schedule no later than November 20, 2015.

4. The Staff of the Missouri Public Service Commission, the Office of the Public

Counsel, Brightergy, LLC, Missouri Industrial Energy Consumers, Earth Island Institute d/b/a

Renew Missouri, the National Housing Trust, West Side Housing Organization, Union Electric

Company d/b/a Ameren Missouri, Missouri Department of Economic Development-Division of

Energy, United for Missouri, Inc., and Natural Resources Defense Council have been apprised of

the contents of this status report and motion, and have indicated that they either support or do not

oppose.

WHEREFORE, the Company respectfully requests the Commission extend the deadline

for filing a Stipulation And Agreement by five days to November 18, 2015, and allow the parties

to propose a revised procedural schedule no later than November 20, 2015.
