MOTION FOR ADOPTION OF PROCEDURAL SCHEDULE

Invenergy Transmission LLC, on behalf of itself and its parent company Invenergy Investment Company LLC (together with Invenergy Transmission LLC, "Invenergy"), as well as Grain Belt Express Clean Line LLC ("Grain Belt") on behalf of itself and its parent company Grain Belt Express Holding LLC (jointly, "Joint Applicants") hereby file this Motion for Adoption of Procedural Schedule. In support of this Motion, Joint Applicants state as follows:

1. On February 4, 2019, the Missouri Public Service Commission ("Commission") issued an *Order Directing Notice and Scheduling a Prehearing Conference*, directing that a prehearing conference be held on February 28, 2019.

2. On February 13, 2019, Eastern Missouri Landowners Alliance d/b/a Show Me Concerned Landowners ("Show Me") and Missouri Landowners Alliance ("MLA") filed applications to intervene in the above-captioned matter. On February 14, 2019, Joseph and Rose Kroner (the "Kroners") filed an application to intervene, and on February 18, 2019, the Missouri Joint Municipal Electric Utility Commission ("MJMEUC") filed an application to intervene. Renew Missouri Advocates d/b/a/ Renew Missouri ("Renew Missouri") filed an application to intervene on February 25, 2019. No other parties have petitioned for intervention as of the date of this Motion. 3. In anticipation of the prehearing conference scheduled for February 28, 2019, Joint Applicants prepared a draft procedural schedule and circulated the draft schedule to counsel for the Commission Staff, Show Me, MLA, the Kroners, MJMEUC, and Renew Missouri. After receiving input from all parties, Joint Applicants assert that the schedule set forth below is agreeable to all parties. Counsel for all parties have indicated that Joint Applicants may state that the parties are in agreement with the proposed schedule.
