COMES NOW, Union Electric Company, d/b/a Ameren Missouri (“Ameren Missouri” or “Company”), and for its Motion for Continuance, states as follows:

1. By Notice of Hearing and Order Setting Prehearing Conference dated April 11, 2011, the Commission set this matter for evidentiary hearing on the merits of the complaint on Monday, April 25, 2011 at 10 a.m.
2. On April 25, 2011, outside counsel for the Company, Sarah E. Giboney, will be engaged in the second week of a two-week jury trial in Case No. 06BE-CC00038 in the Circuit Court of Benton County, Missouri, and therefore will be unavailable for the evidentiary hearing in this matter, as scheduled.
