### MOTION FOR EXPEDITED TREATMENT

COMES NOW KCP&L Greater Missouri Operations Company ("KCP&L-GMO" or "Company"), pursuant to Missouri Public Service Commission ("Commission") Rule 4 CSR 240-2.080(16), and respectfully submits its Motion for Expedited Treatment in the above-referenced matter. In support of its Motion, Company respectfully states as follows:

- 1. On October 15, 2009, Company filed steam service tariff sheets providing the current Quarterly Cost Adjustment for service provided to steam customers in the company's St. Joseph, Missouri, and environs service territory. Those tariff sheets were assigned Tariff No. YH-2010-0283, and reflected an effective date of December 1, 2009. By its Order Directing Filing issued in this matter on October 21, 2009, the Commission set a November 13, 2009 date for the filing of a recommendation from its Staff and for any other responses to the tariff.
- 2. Due to an error in the calculation identified through the Commission Staff's review, Company withdrew the YH-2010-0283 tariff filing and filed tariff sheets containing the required correction on November 12, 2009, said tariff sheets reflecting an effective date of December 12, 2009. This filing was assigned **Tariff No. YH-2010-0338**, and copies of the filing were served on all counsel of record in this case. As these

tariff sheets reflect a thirty (30) day effective date of December 12, 2009, Company is requesting expedited treatment in approving these tariff sheets so they will become effective on the original December 1, 2009 date.

- 3. In accordance with Commission Rule 4 CSR 240-2.080(16), Company requests that the Commission act as soon as reasonably possible given the Commission's Agenda schedule. Company understands that the Commission Staff will be making its Recommendation on today's due date, and that the Staff does not oppose the specific relief requested herein. Whereas this tariff filing was required to correct a calculation error in a previous tariff filing bearing a December 1, 2009 effective date, Company respectfully submits that good cause exists for granting this expedited treatment request. There will be no negative effect on the Company's customers or the general public if the commission acts as requested herein.
- 4. As the subject tariff sheets were just filed on November 12, 2009, this pleading was filed as soon as it could have been.

WHEREFORE, KCP&L Greater Missouri Operations Company respectfully submits its Motion for Expedited Treatment and respectfully requests that the Commission grant the relief requested herein.
