MOTION FOR EXPEDITED TREATMENT

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") and, pursuant to 4 CSR 240-2.080, submits its Motion for Expedited Treatment and states as follows:

1. A *Non-Unanimous Stipulation and Agreement* ("Stipulation") was filed in this case on January 12, 2016, by Ameren Missouri, the Missouri Public Service Commission Staff ("Staff") and Missouri Industrial Energy Consumers ("MIEC").

2. The Missouri Public Service Commission ("Commission") issued an Order effective January 27, 2016, approving the Stipulation ("Order").

3. Consistent with the Stipulation and the Order, Ameren Missouri has filed a new revised tariff sheet that reflects the FAR rates without the N factor adjustment.

4. Ameren Missouri requests that the tariff sheet be approved so it is effective on January 27, 2016. Good cause exists for this request in that it is necessary for customers to receive the rate decrease proposed in this filing. All parties to the Stipulation agreed that the tariff sheet should take effect on January 27, 2016. The Order requires Ameren Missouri to file the tariff and a Motion for Expedited Treatment so that the tariff may become effective by January 27, 2016.

5. Ameren Missouri has filed this Motion for Expedited Treatment as soon as possible after the Order was issued by the Commission approving the Stipulation. There will be

no negative effect on Ameren Missouri's customers or the general public in granting this request for expedited treatment.

WHEREFORE, Ameren Missouri respectfully requests the Commission issue an Order approving the new revised tariff so that it is effective no later than January 27, 2016.
