**MOTION FOR EXPEDITED TREATMENT
AND CANCELLATION OF TARIFFS**

COMES NOW Missouri-American Water Company (MAWC), and, in accordance with Missouri Public Service Commission (Commission) Rule 4 CSR 240-2.080(16), moves the Commission for expedited treatment of MAWC's tariff sheet, filed on March 15, 2012:

1. On March 7, 2012 (effective March 16, 2012), the Commission issued its Order Approving Non-Unanimous Stipulation and Agreement.
2. As part of the Approved Non-Unanimous Stipulation and Agreement, signatories asked that new rates be allowed to go into effect on April 1, 2012.
3. On March 15, 2012, MAWC filed tariffs sheets in order to comply with Paragraph 9 of the Commission Order (Sewer Service – P.S.C. MO. NO. 7, P.S.C. MO. NO. 8, P.S.C. MO. NO. 10, P.S.C. MO. NO. 12, P.S.C. MO. NO. 14, Water Service – P.S.C. MO. NO. 9, P.S.C. MO. NO. 11, P.S.C. MO. NO. 13, P.S.C. MO. NO. 15).
3. Accordingly, MAWC seeks the Commission's order allowing the proposed tariff sheet to go into effect on April 1, 2012.
4. The subject tariff sheet and this Motion have been filed as soon as possible after the issuance of the Commission's Order.
5. Further and in conjunction with the above matter, MAWC requests cancellation of tariff books St. Louis County – P.S.C. MO No. 6, Jefferson City – P.S.C. MO No. 3, Missouri

Cities – P.S.C. MO No. 4, Joplin – P.S.C. MO No. 2, St. Joseph – P.S.C. MO No. 1, and Warren County Water – P.S.C. MO No. 7.

WHEREFORE, for the foregoing reasons, MAWC respectfully requests the Commission to grant MAWC's Motion for Expedited Treatment and Cancellation of Tariffs and approve MAWC's proposed tariff sheets April 1, 2012, or as soon thereafter as the Commission finds to be reasonable and cancel MAWC's tariff books.


