**STAFF’S MOTION FOR AN EXTENSION TO FILE A STATUS REPORT OR
RECOMMENDATION AND RENEWAL OF STAFF’S MOTION TO ADD PARTIES**

COMES NOW the Staff of the Missouri Public Service Commission (Staff), through the undersigned counsel, and requests the Missouri Public Service Commission (Commission) allow Staff until April 29, 2009, to file a status report or recommendation in this case. Also, Staff renews its March 25, 2009 *Motion to Add Parties* to add the City of Rich Hill, Missouri (Rich Hill) and Osage Valley Electric Cooperative (Cooperative) as necessary parties to this case. For this cause, Staff respectfully states the following:

1. On March 5, 2009, the Commission received an Application from Mr. Harold Caskey, on the behalf of his clients Nancy and Ron Gilkey, Jr. (Applicants). The Applicants request a change in electrical supplier from Rich Hill to the Cooperative.
2. The Applicants state the request for a change in electrical supplier “is due to safety concerns because there is something wrong with their electrical service and they fear there could be a fire.”
3. If an application cites service issues as a reason for the request, 4 CSR 240-3.140 (1)(E) and (F) require the applicant to provide a description of the problems and dates of occurrence, a description of the contacts which applicant has had with the current supplier regarding the problems, and what efforts the current supplier has made to solve the problems.
4. On March 9, 2009, the Commission issued an *Order Directing Filing*, directing the Staff to file a recommendation by April 8, 2009. Staff has submitted data requests to the

Applicants' attorney, and the responses are due April 13, 2009. Therefore, Staff respectfully requests an extension until no later than April 29, 2009, to file a status report or its recommendation.

5. Additionally, on March 25, 2009, Staff filed a *Motion to Add Parties*, requesting the Commission add Rich Hill and the Cooperative as parties to this case. Staff has not received a ruling on that Motion, and will renew it at this time.

WHEREFORE, the Staff requests the Missouri Public Service Commission issue an order which allows until April 29, 2009, to file a status report or recommendation in this case, and adds the City of Rich Hill, Missouri and Osage Valley Electric Cooperative as necessary parties to this case.
