MOTION FOR PROTECTIVE ORDER

COME NOW Entergy Arkansas, Inc. (“EAI”), Mid South TransCo LLC (“Mid South TransCo”), Transmission Company Arkansas, LLC (“TC Arkansas”) and ITC Midsouth LLC (“ITC Midsouth”) (collectively, “Joint Applicants”), pursuant to 4 CSR 240-2.135 and hereby move the Commission to issue a protective order on the following grounds:

1. Joint Applicants have herewith filed their Joint Application, which includes attachments that contain confidential information. Such information has been designated proprietary pursuant to Rule 4 CSR 240-2.135.

2. The Commission has recognized in numerous cases that there is a genuine need to protect confidential information from disclosure.

3. In this case, certain information which is considered to be highly confidential or proprietary will be involved and this information should not be made public. Such information is not publicly available in other documents and Joint

Applicants would suffer significant negative business consequences if it were to be made public.

4. The Commission should establish a protective order authorizing the continued confidentiality of the information attached to the Joint Application and similar information that may be provided with other pleadings in this case, subject to the terms of 4 CSR 240-2.135.

WHEREFORE, Joint Applicants respectfully request the Commission to issue a protective order.
