STAFF'S MOTION FOR ADDITIONAL TIME TO FILE PROCEDURAL SCHEDULE

Comes now the Staff of the Missouri Public Service Commission (Staff), by counsel, and for its Motion for Additional Time to File Procedural Schedule states as follows:

- 1. On September 7, 1999, HJN Telecom, Inc. (HJN), a Georgia corporation, filed its Application for a Certificate of Service Authority to provide Basic Local Telecommunications Services in Portions of the State of Missouri and to Classify Such Services and the Company as Competitive.
- 2. On September 14, 1999, the Commission issued its Notice of Application and deadline for intervention. On October 7, 1999, Southwestern Bell Telephone Company (SWBT) filed its timely application to intervene which the Commission granted on October 19, 1999. No other parties intervened.
- 3. On October 20, 1999, the Commission issued a corrected Order setting a Prehearing Conference on November 8, 1999 and the filing of a Proposed Procedural Schedule by 3:00 P.M. on November 15, 1999.
- 4. The parties advised the Commission they anticipated settlement and on November 8, 1999, the Commission issued its Order Canceling Prehearing Conference in which it canceling



the prehearing conference and ordered the parties to file a proposed stipulation and agreement by November 15, 1999, if they had not filed a stipulation and agreement by that date.

5. HJN has advised the Staff that is has approval from SWBT to enter into a stipulation and agreement; however, the Staff is requiring HJN make an additional filing with the Commission disclosing additional information regarding the technical expertise of the applicant. HJN, today, has disclosed to Staff the additional information it proposes to file. When HJN files with the Commission the additional information as disclosed to the Staff, the Staff is prepared to enter into a stipulation and agreement for filing in this case which will resolve all issues.

WHEREFORE, the Staff respectfully moves the Commission to grant the parties until Monday, November 22, 1999, to file a Stipulation and Agreement or Procedural Schedule.
