**MOTION TO ACCEPT CORRECTIONS TO AMEREN MISSOURI WITNESS  
RICHARD A. VOYTAS’ PREFILED DIRECT AND REBUTTAL TESTIMONY**

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Company”), and in filing its Motion to Accept Corrections to Ameren Missouri Witness Richard A. Voytas’ Prefiled Direct and Rebuttal Testimony (“Motion”) states as follows:

1. It has come to Ameren Missouri’s attention that there are minor errors in the prefiled Direct and Rebuttal Testimony of Ameren Missouri witness Richard A. Voytas.

2. Accordingly, Ameren Missouri seeks leave of the Commission to make the following corrections:

a. **DIRECT TESTIMONY 10/22/14:**

On pages 1-63, any and all references to “Mr. Marke” should read “Dr. Marke”

On page 37, lines 15-24, beginning at the end of line 15 with “But more...” through line 24, all text should be stricken completely

On page 61, line 5, the text should read “Yes, he certainly is. As the 2012 Stipulation shows, the performance incentive is not part of”

b. **REBUTTAL TESTIMONY 11/17/14:**

On pages 1-16, any and all References to “Mr. Marke” should read “Dr. Marke”

On page 13, line 14, the line should read “by a scholar that supports a conclusion that is 180 degrees opposite of what Dr. Marke”

3. The above corrections in no way alter the conclusions made in Ameren Missouri witness Richard A. Voytas’ Direct or Rebuttal Testimony. Attached are corrected versions of Mr. Voytas’ testimony reflecting the corrections identified above.

WHEREFORE, Ameren Missouri respectfully requests the Commission accept its Motion to Accept Corrections to Ameren Missouri Witness Richard A. Voytas' Prefiled Direct and Rebuttal Testimony.
