## **INITIAL CUSTOMER NOTICE**

July 14, 2005

## Dear Customer:

On June 24, 2005, The Empire District Electric Company (Company) submitted a request to the Missouri Public Service Commission (Commission) for an increase in its water rates, under the Commission's small company rate increase procedure.

We are seeking an annual increase in revenues of approximately \$522,835, or 38%. The increase is necessary due to increased operating expenses and to recover approximately \$1.4 million in improvements, upgrades, and additional extensions which have been made to meet the growing needs of customers. We are also requesting changes to our service charges and connection fees. Changes to our general business practices, customer service practices, general tariff provisions, and the design of our customer rates, may also occur.

The table on the back of this notice shows a comparison of current and proposed rates and the requested changes in our connection fees for new location connections. The bill comparison is based upon a monthly usage of 6,000 gallons.

Before changes are made to our rates, the Staff of the Public Service Commission (Commission Staff) will conduct a thorough audit of our operations. The Office of the Public Counsel (OPC), a state agency representing the interests of utility consumers, may also conduct an audit, but at a minimum will review the Commission Staff's audit.

Any customer who has questions or comments regarding the rate request or recent service-related issues should contact the Commission Staff and/or the OPC within 30 days of this notice. Please use the addresses, telephone numbers, fax numbers, or e-mail addresses shown here and include a reference to request number QW-2005-0012. As a part of their investigation, the Commission Staff and the OPC will review all customer comments.
