**REQUEST OF CLEARWORLD COMMUNICATIONS
CORPORATION TO EXTEND THE FILING
DATE FOR ITS ANNUAL REPORT**

COMES NOW Clearworld Communications Corporation ("Clearworld"), by and through its attorneys and, pursuant to 4 CSR 240-10.080(8), respectfully requests the Missouri Public Service Commission ("Commission") to extend the filing date for its Annual Report. In support of its request, Clearworld states as follows:

1. Clearworld is a certificated interexchange carrier in Missouri with its principal place of business located at 3100 S. Harbor Blvd., Suite 300, Santa Ana, California 92704.
2. As a telecommunications utility subject to the jurisdiction of the Commission, Clearworld is required to file annual reports with the Commission each year by April 15, on a form provided by the Commission or on a computer generated replica which is acceptable to the Commission (4 CSR 240-10.080(1)&(4).
3. The attached "Annual Report of Clearworld Communications Corporation for the year ended December 31, 1999" was duly prepared and mailed for filing with the Commission on April 14, 2000, as an officer of Clearworld erroneously believed that the post mark date would constitute the date of filing. Accordingly, said document was returned by the Commission to Clearworld with accompanying correspondence dated April 28, 2000. As a result, Clearworld

respectfully requests an extension of time to today, to file its attached Annual Report for the year ending December 31, 1999.
