

**MOTION FOR LEAVE TO FILE  
ANNUAL REPORT OUT OF TIME**

Comes now Worldwide Fiber Networks, Inc. ("Worldwide" or "Company") and for its Motion for Leave to File Annual Report Out-of-Time states to the Missouri Public Service Commission ("Commission") as follows:

1. Pursuant to 4 CSR 240-10.080(1), all public utilities subject to the jurisdiction of the Commission shall file an annual report on or before April 15. Worldwide is a newly-certificated telecommunications company subject to the jurisdiction of the Commission. Worldwide received its Missouri certificate of authority to provide telecommunications services on November 17, 1999. Thus the report for 1999 is the first Annual Report filed by the company.

2. During the previous year, Worldwide applied for and received certification in several states which made completing its year-end financial reports more difficult and prohibited Worldwide from being able to prepare its annual report in a timely manner. Worldwide respectfully requests that the Commission grant its Motion for Leave to File Annual Report Out-of-Time and accept the report for filing. No party should be prejudiced by the delay.

Wherefore, Worldwide respectfully requests that the Commission grant its Motion for Leave to File Annual Report Out of Time and accept the attached 1999 Annual Report for filing.
