

**MOTION FOR LEAVE TO FILE
ANNUAL REPORT OUT OF TIME**

Come now Axces, Inc. ("Axces") and for its Motion for Leave to File Annual Report Out-of-Time state to the Missouri Public Service Commission ("Commission") as follows:

1. Pursuant to 4 CSR 240-10.080(1), all public utilities subject to the jurisdiction of the Commission shall file an annual report on or before April 15. Axces is a telecommunications company subject to the jurisdiction of the Commission.

2. Because Axces was unable to complete its annual report and file it with the Commission in a timely manner, the report was rejected by the Commission. Because Axces is located in Texas and is a corporation, the motion required by Commission rule had to be filed by a Missouri attorney. Axces has had difficulty locating Missouri counsel to prepare a Motion for Leave to File Annual Report Out of Time and resubmit the report. Axces requests that the Commission accept the report for filing.

Wherefore, Axces respectfully requests that the Commission grant its Motion for Leave to File Annual Report Out of Time and accept the attached 1999 Annual Report for filing.
