NOTICE OF AGREEMENT

COMES NOW Missouri-American Water Company (MAWC or Applicant), and hereby notifies the Missouri Public Service Commission (Commission) of MAWC's Agreement with the Commission Staff (Staff) Recommendation filed on October 29, 2013:

1. On October 29, 2013, the Staff filed a Recommendation that contained a Memorandum describing Staff's review of MAWC's Petition.
2. Having reviewed the October 29, 2013 Staff Recommendation, Memorandum and attachments thereof, MAWC hereby notifies the Commission that it does not object with the rates recommended in the Staff Memorandum and asks that the Commission issue an order as requested by the Staff.
3. However, the Company notes the following language was included in the Staff recommendation: "By this filing, MAWC requests an adjustment to its ISRS rates and charges for ISRS-eligible infrastructure system replacements and relocations made during the period of April 1, 2013 through July 30, 2013." Company notes that the actual period should run through September 30, 2013.
4. The Commission previously suspended MAWC's proposed ISRS tariff sheet (YW-2014-0109) until December 28, 2013. Because there appears to be no necessity for a hearing, MAWC would ask the Commission to act at its earliest convenience.

WHEREFORE, for the foregoing reasons, MAWC respectfully request the Commission consider this Notice of Agreement and thereafter issue an Order authorizing MAWC to file a tariff sheet that corresponds to the Infrastructure System Replacement Surcharge identified in the Staff Recommendation.
