These tariff sheets are being filed to incorporate new, previously unregulated sewer assets of Deer Run Estates Property Owner’s Association into Confluence Rivers’ existing tariff, P.S.C. MO No. 13 pursuant to the Commission’s *Order Granting Certificate of Convenience and Necessity* issued in File No. SA-2022-0299.


In relevant part, Confluence Rivers was directed to “revise P.S.C. MO No. 13 for the addition of Deer Run’s sewer assets, to become effective before closing on the assets. Confluence shall also file tariff sheets for the service area map, service area written description for Deer Run’s sewer assets, and table of contents.”

Each of the tariff sheets, as provided and listed herein, bears an issue date of October 10, 2022, and a proposed effective date of November 9, 2022. Because Confluence Rivers now has a proposed closing date prior to November 9, 2022, it will also be filing a Motion for Expedited Treatment.
