Dear Mr. Woodruff:

Magna5 LLC ("Company" fka X5 OpCo LLC) hereby notifies the Missouri Public Service Commission ("Commission") that effective immediately, the Company is changing its name from X5 OpCo LLC ("X5 OpCo") to **Magna5 LLC**. Evidence of the Company's *Certificate of Amendment* issued by the State of Missouri Secretary of State is attached.

On November 9, 2015, NovaTel Ltd., Inc. ("NovaTel") and X5 OpCo LLC ("X5 OpCo") submitted a joint courtesy *Notification* informing the Commission that X5 OpCo was acquiring assets, including subscriber accounts, of NovaTel, through a mutually negotiated agreement pending grant of X5 OpCo's Certificate of Service Authority. On December 13, 2015, the Commission granted a Certificate of Service Authority to provide interexchange and non-switched local exchange telecommunications services in Missouri to X5 OpCo. And on March 2, 2016, X5 OpCo notified the Commission of the successful consummation of an Asset Purchase Agreement with NovaTel Ltd. and of X5 OpCo's initiation of interexchange telecommunications services in Missouri

The Company's name change to Magna5 LLC is part of a rebranding initiative associated with the Company's completion of the Commission-approved asset acquisitions in Missouri and throughout the U.S., and is not the result of a corporate reorganization or change of control. The Company's operations are otherwise unchanged. Company subscribers are being notified of the name change via billing insert and separate letter.
