ORDER NUNC PRO TUNC

On November 12, 2019,¹ Commission issued its Order Approving PGA Tariff with an effective date of November 15. Therein, the Commission approved three Purchased Gas Adjustment (PGA) tariffs. The three tariffs changed the customers' total PGA to reflect changes in Summit Natural Gas of Missouri, Inc.'s (the Company's) PGA factors as a result of estimated changes in the cost of natural gas for the upcoming season.

On November 13, the Commission Staff filed a *Notice of Correction to Staff Recommendation*. Therein Staff stated its November 8 recommendation contained a transposition error. The recommendation incorrectly stated that "[t]he changes applicable to the Company's Rogersville and Branson Divisions will decrease the firm sales customer's Total PGA from \$0.4599 per Ccf to \$0.3381 per Ccf." It also incorrectly stated "[t]he proposed change represents a \$0.1218 per ccf. decrease."

The tariff sheet which the Commission approved is P.S.C. MO No. 3 5th Revised Sheet 58, canceling 4th Revised Sheet 58. The approved tariff sheet provides that the PGA factors applicable to the Company's Rogersville and Branson Division will decrease the firm sales customer's Total PGA from \$0.4599 per Ccf to \$0.3318 per Ccf. The change

represents a \$0.1281 decrease. The Commission will amend its November 12 Order nunc pro tunc to correctly state what the approved PGA tariff provides.

THE COMMISSION ORDERS THAT:

1. The following language in the Commission's November 12, 2019 Order shall be corrected:

"The changes applicable to the Company's Rogersville and Branson Divisions will decrease the firm sales customer's Total PGA from \$0.4599 per Ccf. to \$0.3381 per Ccf. The proposed change represents a \$0.1218 per Ccf decrease."

2. The aforesaid language shall be corrected to read:

"The changes applicable to the Company's Rogersville and Branson Divisions will decrease the firm sales customer's Total PGA from \$0.4599 per Ccf to \$0.3318 per Ccf. The proposed change represents a \$0.1281 decrease."

3. This order shall become effective when issued.
