1. With this Motion, the Company is filing revised tariff sheets in compliance with the Commission's Report and Order issued March 2, 2016. That Report and Order authorized the Company to file tariff sheets in compliance with the order and a motion for expedited treatment.

2. The subject tariff sheets carry an effective date of April 15, 2016. The Company seeks the Commission's expedited treatment of these tariff sheets. To that end, the Company asks that the tariff sheet becomes effective April 1, 2016.

3. The grant of this Motion may have a positive benefit for the Company's customers in that the MEEIA Cycle 2 tariffs can go into effect sooner and thus the Company can begin implementing MEEIA Cycle 2 programs. Currently, all Cycle 1 tariffs have expired. Staff supports the Company's request for expedited treatment. This Motion is filed as of the earliest date the Company knew of its necessity and was able to prepare the required documents. There

will be no negative effect on the Company's customers or the general public if the Commission permits the Cycle 2 tariffs to become effective on April 1, 2016.

WHEREFORE, for all the foregoing reasons, the Company respectfully requests the Commission consider this Motion for Expedited Treatment and to approve the proposed MEEIA Cycle 2 tariff sheets effective April 1, 2016.
