ORDER RECOGNIZING NAME CHANGE

On June 13, 2016, GC Pivotal, LLC, filed a letter informing the Commission that it is changing the name by which it provides telecommunications service in Missouri to GC Pivotal, LLC d/b/a Global Capacity.

Staff filed a recommendation on June 22, advising the Commission that the notice of name change complies with the Commission's requirements for a name change, and recommending that the Commission allow the related tariffs filed by the company to go into effect by operation of law. No one has opposed the name change.

The Commission has reviewed the notice of name change and Staff's recommendation. The Commission finds that the name change should be recognized. The Commission notes that GC Pivotal, LLC d/b/a Global Capacity's tariff adoption notice will become effective by operation of law on July 15.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the change of name of GC Pivotal, LLC to GC Pivotal, LLC d/b/a Global Capacity.

2. This order shall be effective when issued.
3. This file shall be closed on June 24, 2016.


