ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING
REQUESTS TO INTERVENE, AND ESTABLISHING TIME
FOR FILING RECOMMENDATIONS

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene and for the filing of recommendations.

On September 1, 2006, Charter Fiberlink-Missouri filed an application under 47 C.F.R. 52.15(g)(3)(iv)-4, requesting that the Commission review and reverse a decision of the North American Numbering Plan Administrator, NeuStar, Inc., to withhold certain numbering resources from Charter in the form of a new block of 10,000 numbers to meet the needs of customers in the Festus-Crystal City rate center.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications

company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and establish a date by which any other party wishing to respond must file a recommendation.

IT IS THEREFORE ORDERED:

1. That the Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.

2. That any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than September 26, 2006, with:
