**MOTION FOR EXPEDITED TREATMENT**

Comes now McDonald County Telephone Company ("McDonald County"), pursuant to 4 CSR 240-2.080(16), and for its Motion for Expedited Treatment states to the Missouri Public Service Commission ("Commission") as follows:


1. On this same date, McDonald County is filing revised tariff sheets which add a new Custom Calling Service, Call Waiting ID, and add two new Customer Calling packages, Basic Calling Feature Package and Extended Calling Feature Package. McDonald County is filing these sheets with a thirty-day effective date as required by Commission rule.

2. Because McDonald County's marketing plan for the new service and packages is scheduled to begin on May 1, 2006, McDonald County requests that the Commission expedite the approval of these tariff revisions and allow them to take effect on May 1.

3. These tariff sheets were not filed earlier because there was an unavoidable delay in their preparation. McDonald County requests that the Commission approve this tariff on an expedited basis so that the company may offer the new service and packages to its customers as soon as possible in coordination with its marketing plan.

Wherefore McDonald County Telephone Company respectfully requests that the Commission grant its Motion for Expedited Treatment and approve the tariff sheets authorizing it to offer the new service and packages to its customers as quickly as possible.


