## MOTION FOR EXPEDITED TREATMENT OF REVISED TARIFF SHEETS

COMES NOW McLeodUSA Telecommunications Services, Inc. (McLeodUSA), by and through counsel, and pursuant to 4 CSR 240-2.065(2) and 4 CSR 240-2.080(16), for its Motion for Expedited Treatment for Approval of Revised Tariff Sheets ("Motion"), states as follows:

- 1. Contemporaneous with this Motion, McLeodUSA is filing revised tariff sheets to implement International Blocking and Wholesale Services description in its local exchange telecommunications service tariff. This tariff revision is a re-filing of the tariff pages containing the non-controversial revisions from Tariff Filing No. JC-2004-1048, Case No. CT-2004-0497, which was closed on April 27, 2004. McLeodUSA respectfully requests the Commission grant expedited treatment of these tariff revisions and permit them to take effect on less than 30 days notice. Specifically, McLeodUSA requests the tariff sheets be allowed to take effect on May 9, 2004.
- 2. In CT-2004-0497, McLeodUSA sought to implement a new charge (Account Handling Charge), which raised questions by Commissioners and resulted in suspension of the entire tariff filing. Certain pages of the tariff filing were not controversial. However, because McLeodUSA was informed that it could not withdraw only a portion of the suspended tariff (namely the controversial pages), McLeodUSA moved to withdraw the tariff filing in its entirety, stating that it intended to refile the

portions of the local exchange tariff (P.S.C. MO No. 4) that appeared to be non-controversial.

- 3. As a result of the suspension, non-controversial revisions on certain tariff pages were not allowed to take effect on a timely basis in relation to the date the sole customer of this service was notified of the change.
- 4. McLeodUSA is re-filing the non-controversial portion of Tariff Filing No. JC-2004-1048, and this Motion for Expedited Treatment, at the earliest possible time after receiving the Commission's Notice Closing Case No. CT-2004-0497. The interest to be served by granting this Motion is that the tariff changes will be allowed to take effect on the date the only customer affected by this tariff change were notified it would take effect.

WHEREFORE, for the reasons stated above, McLeodUSA respectfully moves the Commission to grant expedited treatment of the subject revised tariff sheets pursuant to 4 CSR 240-2.065(2) and allow the tariff sheets to take effect on May 9, 2004.
