MOTION TO SUBSTITUTE MDNR EXHIBIT NO. 7(HC)

COMES NOW the Missouri Department of Natural Resources (MDNR) and for its Motion to Substitute MDNR Exhibit No. 7(HC) states as follows:

On August 1, 2011, a hearing was held in the above-referenced case to address certain concerns raised by several parties with regard to KCP&L General Missouri Operations' (GMO's) revised IRP filing. During the hearing, MDNR Exhibit No. 7 (HC) was admitted into evidence. However, after the hearing, MDNR met with GMO and discovered errors on one of the spreadsheets to Exhibit No. 7 (HC). Specifically, on the spreadsheet entitled *MDNR Workpapers, EE-2009-0237, Sheet 3: "Comparison of DSM portfolios, Demand"* the three columns under *Plan Information from 1/18/2011* required recalculation. MDNR has produced a revised Sheet 3, and respectfully requests the Commission to substitute the revised page. All data on Sheet 3 is considered highly confidential; therefore, both HC and NP versions are attached. It should further be noted that these revisions do not

change or alter the testimony provided by MDNR's witness, Dr. Adam Bickford.
