

REQUEST FOR EXTENSION OF TIME FOR FILING ANNUAL REPORT

Comes now Williams Communications, Inc., d/b/a Vyvx, Inc. ("Williams"), and hereby request an extension of time to file its 1999 annual report. In support of its request, Williams states as follows:

1. Pursuant to 4 CSR 240-10.080(1) & (4), Williams is required to file its Interexchange Telecommunications Company Annual Report ("annual report") with this Commission.

2. Pursuant to 4 CSR 240-10.080(1), Williams's annual report was to be filed with the Commission on or before April 15, 2000.

3. The annual report was not filed with the Commission by April 15, because the Williams employee responsible for filing the annual report ceased employment with Williams prior to April 15 without filing the report. In the process of examining the employee's responsibilities, it came to Williams's attention that the annual report had not been filed.

4. Williams is simultaneously filing the annual report along with this request for extension of time to file the annual report.


5. 4 CSR 240-10.080(8) states:

A utility which is unable to meet the filing date established in section (1) of this rule shall make a written request to extend the filing date for its annual report to the executive secretary and state the reason for the extension request.

6. Pursuant to 4 CSR 240-10.080(8) and the reason stated in paragraph 3 above, Williams requests an extension of time in order to file its annual report, which is being filed simultaneously with this request.

WHEREFORE, Williams requests that the Commission grant Williams an extension of time to file the annual report pursuant to 4 CSR 240-10.080(8).
