MISSOURI DEPARTMENT OF NATURAL RESOURCES' MOTION FOR EXTENSION OF FILING DEADLINE

On February 5, 2008, Union Electric Company, d/b/a AmerenUE, filed its 2008 Integrated Resource Plan pursuant to 4 CSR 240-Chapter 22. According to 4 CSR 240-22.080(5) and (6), the other parties to this proceeding would have until June 4,2008, to file their response to Ameren's IRP filing.

The Missouri Department of Natural Resources requests a fourteen day extension of that deadline. Recent rate case filings, cost of service filings, rule drafting activities and other matters have drawn off resources needed to fully address Ameren's IRP.

The Office of Public Counsel and Staff support this request. Ameren has indicated that it will not oppose an extension from June 4, 2008, to June 18, 2008, to file the responses. MDNR has contacted the remaining parties, and none of them have expressed an objection to this request.

WHEREFORE, the Missouri Department of Natural Resources respectfully requests that the Commission extend the filing deadline for parties to respond to Ameren's Integrated Resource Plan by fourteen days until June 18, 2008.
