MOTION FOR NAME CORRECTION NUNC PRO TUNC

Comes now Peace Valley Telephone Co., Inc., by and through counsel, and requests an Order of the Commission correcting the matters appearing in its Order Granting Application dated June 29, 1988 to reflect the action actually taken. In support thereof, Movant states that:

1. On June 29, 1988, the Commission issued an Order Granting Application which authorized Quinter Bosserman d/b/a Peace Valley Telephone Company to transfer its franchise, facilities and system to Peace Valley Telephone Company, Inc., a Missouri corporation.

2. The official name of the Transferee as it appears in its corporate charter is Peace Valley Telephone Co., Inc., not Peace Valley Telephone Company, Inc. See, Exhibit 1 of the Application.


3. The Commission's June 29, 1988, Order Granting Application should be corrected to reflect the official name of the Transferee so as to avoid any ambiguity about the authority of

Peace Valley Telephone Co., Inc. to operate as a telecommunications company in the State of Missouri.

4. The correction requested herein is merely for the purpose of supplying a correction to reflect the action really taken but omitted through inadvertence.

WHEREFORE, Peace Valley Telephone Co., Inc. requests that this Commission issue a correction of name by an Order Nunc Pro Tunc to reflect the official corporate name of the Transferee in this proceeding.
