

MOTION FOR ONE-DAY EXTENSION OF TIME TO SUBMIT  
PROPOSED FINDINGS OF FACT, CONCLUSIONS OF LAW

COME NOW Intervenor AG PROCESSING INC, A COOPERATIVE ("AGP"), FRISKIES PETCARE, A DIVISION OF NESTLE USA ("Friskies") and WIRE ROPE CORPORATION OF AMERICA INC. ("Wire Rope") (collectively herein "St. Joseph Industrial Intervenor") and seek a one-day extension within which to submit proposed findings of fact and conclusions of law and in support thereof state:

1. Proposed findings were not required but were to be submitted if desired by August 11, 2000 by 4:00 p.m.
2. Although intending to do so, electronic transmittal of the document for its filing has been prevented by presently unknown difficulties that interfere with its transmission to Jefferson City.
3. While the precise reason for the transmission difficulty is not presently known, expectations are that it will be repaired or corrected later in this day but not in sufficient time to make the filing deadline.

4. No party will be prejudiced by this extension and it is anticipated that both hard and electronic copies will be submitted to the Commission on the following business day, August 14, 2000 shortly after the records office opens. It is also possible that electronic copies will be distributed to the Regulatory Law Judge and the parties at an earlier date when the condition is repaired.

WHEREFORE, these parties pray this brief extension to complete their filing.
