## MOTION FOR EXTENSION OF TIME

Comes now the Office of the Public Counsel (Public Counsel) and for its Motion for Extension of Time in which to file its recommendations addressing procedural alternatives in the above docket hereby states as follows:

 That on November 3, 1986, this Commission issued an order establishing Docket No. AO-87-48 for the purpose of investigating the effect upon the revenue requirements of utilities of the Tax Reform Act of 1986.

2. That in said November 3. 1986, order, this Commission established a date of January 5, 1987, for the filing by this office and the Staff of the Commission of comments as to the proper procedure to be followed to recognize the revenue effect of the changes in the tax law.

3. That on December 8, 1986, the Staff of the Commission requested an extension of time to file its recommendations to January 9, 1987. This request was granted by the Commission by its order dated December 17, 1986.

4. That Public Counsel hereby requests that it also be granted an extension of time to January 9, 1987, in which to file its comments. Reasons for this request include the demands of the holiday season, the late filings of reports by AT&T Communications and Union Electric and the recent filing of a complaint by the Commission Staff against General Telehone of the Midwest. All of these factors affect the undersigned attorney's ability to prepare, edit and review the comments requested in this docket by the currently established date.

WHEREFORE, Public Counsel requests that this Commission grant its motion to extend the time by which its comments are due in the above docket to January 9, 1987, and for such further relief which to this Commission may seem just and proper.
